- Hold will be removed when the unit is returned in undamaged condition, reasonable wear and tear excepted.
- If a customer has an insurance deposit will be returned once insurance has paid - any deductible comes from the deposit.
- Cleaning charges will apply to units returned with excessive dirt.
- Cost of refueling the unit will be deducted from the deposit if it is not returned fully fuelled.
- Customer is responsible for pick-up and delivery of the unit unless arranged otherwise.
- Unit must be returned full of regular gas. Oil is required for all 2-stroke snowmobiles.

- a) THE RENTAL PERIOD: Each day is 24 hours from the time of receipt of the snowmobiles. Late charges accumulate at the rate of \$100/hour if the snowmobiles are more than 2 hours late being returned.
- b) PAYMENT: Payment is due before the machine is picked-up or delivered. Payment is as per the other side of this form.
- c) LOADING, UNLOADING AND TRANSPORTATION: Northern Sports Rentals Inc. shall assist the customer to load the snowmobiles on a trailer. The representative of Northern Sports Rentals Inc. will not permit the snowmobiles to be loaded on a trailer or in a manner which he deems to be unsafe. The customer will arrange for delivery in this case.
- d) MAINTENANCE, OPERATION AND REPAIR: The customer declares that he or she understands the operation of the equipment. Northern Sports Rentals Inc. will provide basic instruction. The customer should not have to do any maintenance on the snowmobile other than possibly changing the drive belt. A spare belt is supplied. Customer shall not remove, alter, disfigure or cover up any numbering, lettering or insignia

displayed upon the equipment, and shall ensure that the equipment is not subjected to careless or needlessly rough usage, and shall at the customer's own expense maintain and ultimately return to Northern Sports Rentals Inc. the equipment and its appurtenances in good repair and operating condition.

- e) **FUEL AND OIL:** The customer is responsible for fueling the snowmobiles during the rental period and will return the snowmobiles fully fuelled with regular gasoline at the end of the rental period. It is the customer's responsibility to ensure that there is sufficient oil in all two-stroke snowmobiles at all times. Northern Sports Rentals Inc. will supply the customer with the oil and show where and how to add the oil.
- f) **LIABILITY OF THE CUSTOMER:** The customer shall indemnify Northern Sports Rentals Inc. against all loss, expenses, penalties, damages, condemnations, and legal costs which Northern Sports Rentals Inc. may suffer or may be required or condemned to pay for personal injuries (including death) and/or property damage suffered by any person by reason of the operation, handling, transportation or use of the snowmobiles during the rental period.
- g) **LIABILITY OF NORTHERN SPORTS RENTALS INC.:** The liability of Northern Sports Rentals Inc. is limited to its express obligation to deliver the snowmobiles in good condition and working order and Northern Sports Rentals Inc. shall not be liable for any direct or indirect loss or damage of the customer arising from any failure of the equipment or from its lack of suitability for the conditions encountered by the customer. Any liability shall be limited to rental paid by the customer.
- h) **TITLE:** The equipment shall at all times remain the property of Northern Sports Rentals Inc. and nothing contained in the agreement shall be deemed to have the effect of conferring upon the customer any right or title whatsoever in or to the equipment.
- i) **INSURANCE:** Northern Sports Rentals Inc. provides full insurance for the snowmobiles and any trailers rented with a deductible of \$3,000.00 for which the customer shall be responsible if any claim is made.
- j) **USE OF THE UNIT:** Only the customer and those who have provided a valid driver's license or a valid snowmobile license to Northern Sports Rentals Inc. may operate the snowmobiles.
- k) **PURPOSE:** The snowmobiles may only be used for recreational purposes and may not be re-rented or used for any commercial purposes.
- l) **"NORTHERN SPORTS RENTALS INC."** certifies that the snowmobiles are in good mechanical and physical condition. Any known damage or problems will be listed on this rental agreement. If the unit or equipment has damage or problems not listed on this agreement, the renter must notify "NORTHERN SPORTS RENTALS INC." before use of the unit begins and on the first day of rental.
- m) The renter acknowledges and understands that the snowmobiles are to be left in clean, undamaged condition, in the same condition at commencement of the rental period. If rental equipment is not left in suitable condition, the renter acknowledges and understands that "NORTHERN SPORTS RENTALS INC." reserves the right to charge the renter for any repairs or special cleaning. Additionally, the renter understands and agrees that "NORTHERN SPORTS RENTALS INC." reserves the right to charge for any damages, repairs, replacement, or special cleaning or any damaged or lost property. The renter understands that by signing this agreement he/she is authorizing "NORTHERN SPORTS RENTALS INC." to charge for any damages sustained using the credit card on file for the rental.

- n) Cancellation Policy. If the renter cancels his/her reservation within 14 calendar days of the reservation, renter shall forfeit their deposit. If the cancellation is due to inclement weather, then the deposit will be applied to an alternate rental date.
- o) I/We agree to assume responsibility for all risks including those listed and others not identified. My participation in the activity is voluntary. All participants in my party have been made aware of the risks and I will be responsible for them. I am not impaired by alcohol or drugs and I do not have any disability or condition that may impair my safe operation of the unit. We elect to participate in the rental use in spite of the risks and potential dangers of operating a snowmobile. We understand that at the total discretion of Northern Sports Rentals Inc. this rental agreement can be terminated when and if there is a question as to the competency or condition of the operator or when weather conditions prevent the safe operation of the unit.
- p) In consideration for the services provided by Northern Sports Rentals Inc. in the rental of a watercraft, I/We for myself and minor children for which I am a parent or guardian and any guests that I may be entertaining, or any representative or heir agree that Northern Sports Rentals Inc. shall have no liability for any injury, death, or damage however caused by operation of the unit and I/We release and discharge Northern Sports Rentals Inc. and its insurer for any damages or injuries however caused.

I/We have read the warnings, acknowledgement of risks, assumption of risks and release of liability. I understand that by signing this document I/We may be waiving our legal rights.
